  - Discussion regarding cancelling meeting vs. quick update
  - Meeting moved to Sept 7
- Annual General meeting
  - Suggestion to hold AGM earlier this year as the week it is typically held falls during school spring break

### 5.0 Administrator/Registrar Report – Erin Boulet

- Registration numbers:
  - Registration has really picked up over the last few days
    - 538 registered in mainstream
    - 62 in house league
    - 34 in Squires
    - 132 in summer camp
  - We are currently sitting at 60% of our registration goal
- Hockey Canada Registry:
  - Continuing to have issued with the new platform
  - Coach qualifications are now visible but there is no reporting feature for exporting.
  - Respect in Sport is no longer visible in coach profiles
  - Coach clinics are still not up on the Hockey Alberta website
    - Still have no plans to host in person clinics
  - Hockey Alberta still has not announced plans to host officials clinics

### 6.0 Off Ice Consultant/Ice Scheduler Report – Lisa Rosier

- On Ice
  - Evaluation schedule won't be finalized until we are closer to our final registration numbers
  - Town Hall meetings have been booked. They will be held virtually by age group. There will be a sign in to take attendance.
    - Town Hall meetings are mandatory
    - Age group coordinator meetings are booked
    - Joust in the South tournaments are all booked
    - Hockey Calgary is doing tournaments differently this season:
      - o Deadline to submit
      - Only a certain amount permitted per age division
      - Tournaments are not guaranteed if submitted.
- Off Ice
  - Lake Bonavista is holding a casino on Aug 29 & 30
    - KHC put out a call to the membership looking for 10 volunteers. 15 volunteers signed up!
  - Once the evaluation schedule is done Lisa will start working on evaluation volunteers using Signupgenius.com
  - Picture day is booked for October 16&17 at Midsun community centre
  - Development camps are starting next week
  - Jennifer and Lisa have been working on special events for the season
    - Kick off with a snack drive for Brown Bagging for Calgary kids
      - Anyone who brings in a donation will be entered into a draw
    - Timbit pancake breakfast is planned
    - BBQ on picture day
    - Veterans food bank drive in November
    - Santa Skate and toy drive in December
    - Stand up Speak out in the New Year

## 7.0 Vice President On Ice Report – Bruce Swan

- Has been working with the on ice team to revise the KHC Player Placement Manual
  - Discussion regarding penalty for parents breeching the no spectator policy at evaluations
  - Discussion regarding allowing parents in U7 to spectate
    - Decision to allow parent spectators in U7 with some limitations
  - Expecting pushback from parents regarding the policy
  - Live Barn will stay on during player placement sessions
    - No videos will be reviewed as part of the evaluation review process.
- Question regarding how players are placed if there is no previous team history (ie: coming from HSL)
  - Best effort is made to find out player previous history
  - If no information is available, player starts in bottom group
  - Lots of opportunity to move up during the evaluation process
